Topic/Subject: (GENERAL INVESTIGATION) INTERVIEW C/V

Summary of Investigation:

1. On January 5, 2008, at approximately 1430 hours, I was present at a Brooklyn Ny to speak with c/v Schneur Rotem in regards to this case. Site is the residence of Mr Levi Huebner who I previously spoke to concerning this incident. There was a language barrier between Mr Rotem and myself, so Mr Huebner acted as a translator for me and interpreted what Mr Rotem was saying. Mr Rotem stated that on December 29, 2007 at approximately 2130 hours, he was inside of 749 Eastern Pa rkway Brooklyn NY when several males entered apt 107 and attacked Mr Rotems friends, (Moshe Gurfunkel, Yakum Shatz, Gabriel Brownstein). I inquired if Mr Rotem knows who these individuals were and he advised me that these individuals are members of the Shomrim and that he does know who they are. . It was during this altercation that the police were called. Mr Rotem stated that when the police showed up and the fighting stopped and the men then left the residence. Mr Rotem stated that after the incident he was speaking with his friend Jonathan Gorichnick in the hallway when four of the men re-entered the building and proceeded to attack him. Mr Rotem stated that he received several bruises as well as a fractured hand during this altercation.
