




**Topic/Subject:**  
**(INTERVIEW) C/V GABRIEL BROWNSTEIN**

**Summary of Investigation:**  
 1. On January 9, 2008, at approximately 1815 hours the u/s did interview the c/v Gabriel Brownstein at the 077 Pct Detective Squad in regards to this case. The interview was done through a Hebrew interpreter, Levl Huebner, since the c/v only speaks Hebrew. The interview went as follows:  
 The c/v states he was inside 749 Eastern Parkway, Room #307 when he heard some kind of commotion downstairs. The c/v then went downstairs to the first floor and noticed a fight. The c/v states that Benyomin Lipshitz yelled out "I want him", then grabbed him, shook him around and attempt to tear off his clothes. The c/v then states that Gedalia "Godi" Hershkop punched him in the face and head. The c/v went to Kings County Hospital where he was treated and released with contusions to the face, scalp and neck.

(INTERVIEW) INTERVIEW C/V

**Summary of Investigation:**  
 1. On January 9, 2008, at approximately 1810 HRS I INTERVIEWED THE C/V I/O THE 077 SQUAD OFFICE WITH THE ASSISTANCE OF MR LEVI HUEBENER, [REDACTED] BKLYN NY, WHO ACTED AS INTERPERATOR FOR THE C/V WHO SPEAKS HEBREW. THROUGH MR LEVI HUEBENER THE C/V REPORTED THE FOLLOWING: ON 12/29/07 AT APPROX 2120 HRS I/O 749 EASTERN PKWY, GEDALIA "GADI" HERSHKOP STARTED CHOKING HIM AND PUSHED HIM AGAINST A WALL. THEN YEHUDAH "YUDI" HERSCHKOP PUNSHED HIM THREE TIMES IN THE FACE AND THEN KICKED HIM IN THE HEAD. THE N NOSSI SLATER PUNCHED HIM.  
 2. THE C/V WAS TREATED AT KINGS COUNTY HOSPITAL FOR CONTUSION OF HIS FACE, SCALP AND NECK.

**Summary of Investigation:**  
 1. On January 9, 2008, at approximately 1805 hours the u/s did interview the c/v Moshe Gurfunkel at the 077 Pct Detective Squad in regards to this case. The interview was done through a Hebrew interpreter, Levi Huebner, since the c/v only speaks Hebrew. The interview went as follows:  
 The c/v states on 12/29/07 he was inside the Rabincal School located at 770 Eastern Parkway when he heard that the Shomrim was in 749 Eastern Parkway beating up his brother Shehner. The c/v ran across the street and observe d numerous people in his brothers room. The c/v and his brother then asked everyone to leave the room and while they were leaving, Gedalia "godi" Hershkop; Shalom Willhelm and [redacted] entered and started to punch him about his face and body. The c/v also states that Benyomin Lipshitz, who was inside the room, also attacked him. The c/v states that Gedalia "Godi" Hershkop did punch him on the right eye which caused a fractured cheekbone. The c/v went to Kings County Hospital where he was treated and released.
